ANNEXURE I

Rules and Regulation for Plagiarism Check

- ✓ The scholar should fill all the column of the certificate and sign in specified column.
- ✓ Research Supervisor and Director (R&D) (BU)/ Heads of the Departments also should sign the certificate before submission of the thesis.
- ✓ The scholar should bring the e-Thesis in **CD/DVD** format with a single file containing all chapters.
- ✓ Only the scholar should personally present the Plagiarism check.
- ✓ Permissible similarity level is **30%**
- ✓ If the similarity level of the contents range from 31% 50%, the candidate and the research supervisor have to modify the contents of the document and reduce the similarity level below 30%. The modified document has to be submitted for reevaluation for plagiarism check only after a period of **15days**.
- ✓ If the similarity level is above 50%, the research supervisor has to give a justifiable explanation for the same, the modified document is eligible for re-evaluation only after **30days**.

ANNEXURE III

Plagiarism regulations

The similarity checks for plagiarism shall exclude the following:

- All quoted work reproduced with all necessary permission and/or attribution.
- All references, bibliography, table of content, preface and acknowledgements.
- All generic terms, laws, standard symbols and standards equations

The Plagiarism would be quantified into following levels in ascending order of severity for the purpose of its definition.

- Level 0: Similarities upto 10% Minor similarities, no penalty
- Level 1: Similarities above 10% to 40%
- Level 2: Similarities above 40% to 60%
- Level 3: Similarities above 60%

The regulations as prescribed by UGC on Penalties in case of plagiarism in submission of thesis and dissertations may be followed.

- **Level 0**: Similarities upto 10% Minor Similarities, no penalty.
- Level 1: Similarities above 10% to 40% Such student shall be asked to submit a revised script within a stipulated time period not exceeding 6 months.
- Level 2: Similarities above 40% to 60% Such student shall be debarred from submitting a revised script for a period of one year.
- Level 3: Similarities above 60% -Such student registration for that programme shall be cancelled.
- A mechanism to be created, so as to ensure that each of the paper publication / thesis / dissertation by the student, faculty, researcher or staff of the University / affiliated college is checked for plagiarism at the time of forwarding / submission.





If there is any complaint of plagiarism against the Head of the University / affiliated college / research institution, a suitable action, in line with these regulations, shall be taken by the Controlling Authority of the education institution.
